I wish to allow my child under my legal guardianship ("child") to volunteer with San Diego LGBT Pride. In consideration of San Diego LGBT Pride providing my child with the opportunity to perform volunteer activities, I hereby agree, for myself, my heirs, assigns, executors, administrators and co-parents and co-guardians, to be legally bound hereby and waive, release, and forever discharge San Diego LGBT Pride and its nonprofit partner agencies, its officers and directors, members, partners, funders, employees, agents, and volunteers ("Releasees") from any and all liability, causes of action, suits, proceedings, damages, judgments, claims and demands whatsoever arising out of my child's participation as a San Diego LGBT Pride volunteer or in any San Diego LGBT Pride related activity.

I am aware and agree that there are inherent risks of injury to my child, my child's property and third parties arising from volunteer activities typically performed by San Diego LGBT Pride volunteers, and which may be performed by my child as a San Diego LGBT Pride volunteer. I hereby give permission for my child to participate in all age appropriate activities through San Diego LGBT Pride and expressly and specifically acknowledge that those activities may involve (a) physical activity (including without limitation work with heavy tools and materials), (b) contact with unidentified and unfamiliar persons, (c) travel to and from various unspecified locations, and (d) other potential risk of injury. Notwithstanding the preceding sentence, I willingly and freely assume all such risk and damage to person or property arising there from, whether or not resulting from negligence, and agree to release San Diego LGBT Pride and its Releases from any and all liability, actions, causes of action, claims and demands of every kind and nature whatsoever which I now have or which may arise out of or in connection with my child's volunteer services as a San Diego LGBT Pride volunteer or in any San Diego LGBT Pride related project or activity.

I hereby release San Diego LGBT Pride from liability for any loss or damage of personal property while participating in volunteer activities with San Diego LGBT Pride.

I hereby grant San Diego LGBT Pride and their legal representatives the absolute right and permission to copyright, use and publish images in which I may be included in whole or in part, or composite or distorted in character form, for use in published materials, illustration, promotion, art, advertising, trade, web sites and any other purpose in order to promote San Diego LGBT Pride. I hereby waive any right that I may have to inspect or approve the finished product.
